Under the guidance and hard work of Fr. Ryan, Mrs. Spano, and a very dedicated faculty and staff, St. Christina School strives to provide a top notch, quality education. In order to maintain this high academic standard and meet the day-to-day cost of running our school, a minimal and necessary tuition/fee increase will be implemented beginning with the 2026-2027 school year.

Fr. Ryan and Mrs. Spano are dedicated to exploring every possible way to keep tuition costs as manageable as possible for our families. Realizing the burden these increased tuition costs pose for each of you, the School Advisory Committee continues to look at ways to offer an opportunity for relief. Our RaiseRight (formerly SCRIP) program offers a variety of rebates through the purchase of physical gift cards, eCards as well as shopping online. Many of our school families have been participating in these programs and have collectively earned thousands of dollars in credits that have been applied to their tuition accounts.

Accompanying this letter is the 2026-2027 St. Christina School Tuition Agreement. We ask you to read it carefully and choose the plan that works best for your budget. Please note the volunteer hours, Cardinal Cash Raffle Tickets, and non-registered parishioner sections that you will be responsible for, as in past years, and then electronically sign [HERE](#) a copy of the agreement by **Thursday, April 2, 2026**. As always, we appreciate your support of St. Christina School and value your input. We realize that you have a choice of many schools where you can send your children. We feel St. Christina is a strong school made even better by your presence.

2026 – 2027 St. Christina School Tuition Agreement

The following is the fee schedule for tuition, books, materials and media fees:

PreK 3 thru Grade 8

I, as parent/guardian of a student(s) attending St. Christina School, desire the best education possible for my child/ren and understand my responsibility to finance my children’s education. As part of my commitment to this educational program, I agree to the following policies:

***Sibling discount tuition for two/three/four/five children also applies to PreK students who are enrolled in 5 full days, 4 full days, 3 full days, 4 half days, and 5 half days. The sibling discount is not applicable to PreK students enrolled in 3 half days.**

SACRAMENTAL FEE

Students in grades 2 and 8 will be assessed a \$100 Sacramental fee added to your Blackbaud Tuition Account.

ASSIGNMENT NOTEBOOK FEE

Students in grades 2 through 8 will be assessed a \$5 Assignment Notebook fee which will be added to your Blackbaud Tuition Account.

BLACKBAUD ADMINISTRATIVE FEE

All families are required to have a Blackbaud Tuition Account. There is a \$40 Blackbaud Administrative Fee applied to all accounts annually.

VOLUNTEER COMMITMENT PROGRAM

The volunteer commitment program requires each school family to volunteer ten hours of service in selected activities throughout the school year, as well as selling two Cardinal Cash raffle tickets (\$100/each). Failure to comply with these requirements will result in a charge in your tuition account in April. Choose from the following options:

Option 1: I commit to ten hours of volunteer service to the school and to selling a minimum of two Cardinal Cash raffle tickets. **Please initial here:** _____

Option 2: I choose to opt out of the volunteer requirement. I understand that by checking this box, a \$300 fee will be added to my Blackbaud Tuition account. **Please initial here:** _____

Option 3: I choose to opt out of selling 2 Cardinal Cash raffle tickets. I understand that by checking this box, a \$200 fee will be added to my Blackbaud Tuition account. **Please initial here:** _____

ACTIVE PARISHIONER POLICY

St. Christina School is the primary mission outreach of St. Christina Parish. The Parish helps to defray the cost of tuition by offering a subsidy to each child. The subsidy is totally funded through the regular collection at weekend Masses. The fee structure set on the tuition contract is based on the assumption that a family is considered a registered and “active parishioner”. This status is determined by regular attendance (75% over a 20 week period) at weekend Mass and that enables a family to continue to receive a subsidy from St. Christina Parish for their children’s education. If your family is not a registered and active parishioner (as reflected by Parishioner envelopes or We Share giving) with St. Christina Parish, an additional \$500 fee will be added to your family’s tuition. **Please initial here:** _____

DELINQUENT FINANCIAL OBLIGATIONS

Any School Family who misses two tuition payments and is unwilling to make and/or adhere to alternate arrangements will be subject to actions by the School, up to and including, non-participation in activities and athletics, financial exclusion of their student(s) by withholding of official transcripts, and/or removal from School. In addition, in the event a School Family’s financial obligations have not been met (including all fees and Before/After School Care charges), the School reserves the right to:

- Withhold the diploma of a graduating student
- Deny admission for the student(s) of the delinquent School Family to the School for a new academic term
- Deny admission for the student(s) of the delinquent School Family to the School for the following year

I realize that a continuing delinquency of tuition payments will place an unfair burden on the School and other parents. If my payment program is not kept current, I understand it will necessitate that my child/ren will not receive accreditation records and not be eligible for enrollment the following trimester.
